2 <u>COVID-19 Vaccination Programme "An Update on Vaccination Arrangements for Primary</u> and Secondary Students Aged 12 to 17 years"

The School received a letter from the EDB giving an update to vaccination arrangements for primary and secondary students aged 12 to 17 years. Details are as follows:

2.1 Lowering the age limit for eligibility to receive the Sinovac vaccine "CoronaVac"

With regard to the advice of the Advisory Panel on COVID-19 Vaccines, the Secretary for Food and Health has approved the lowering of the age limit for eligibility to receive the Sinovac "CoronaVac vaccine" ("Sinovac vaccine") to persons aged 3 to 17 years. It has been agreed that adolescents aged 12 to 17 years will be accorded priority in receiving the Sinovac vaccine in accordance with the recommendations made by the Scientific Committee on Vaccine Preventable Diseases and the Scientific Committee on Emerging and Zoonotic Diseases under the Centre for Health Protection of the Department of Health. The decision has been made in conjunction with the Chief Executive's expert advisory panel, with a view to extending the range of eligibility to children of a younger age group at a later stage.

2.2 Vaccination Arrangements for Students

Vaccination is important to protect adolescents against symptomatic COVID-19 disease, and is effective in protecting against severe disease and death from COVID-19 infection. Vaccination is also vital to reduce community transmission, as well as to enable adolescents to resume normal school and daily life as soon as possible. The Government provides persons aged 12 to 17 years with the following two types of COVID-19 vaccines, which are used for preventing COVID-19 caused by SARS-CoV-2 virus;

- Comirnaty vaccine from Fosun Pharma / BioNTech which uses the mRNA technology platform ("BioNTech"). Currently one dose is recommended;
- Sinovac vaccine, which uses the inactivated virus technology (Vero cell) platform, starting from 2nd December 2021. The recommended schedule consists of 2 doses administered 28 days apart.

Please note that students who have already received BioNTech vaccine do not have to receive further doses of Sinovac vaccine.

2.3 Self-arrangement by parents/ guardians and students

Parents and guardians can also make their own bookings at CVCs for their children through the COVID-19 Vaccination Programme website (https://booking.covidvaccine.gov.hk/forms/index.jsp) directly or use the same-day ticket arrangement. Persons aged below 18 years should bring along the completed Consent Form to the CVCs for vaccination.

Students are also encouraged to go to private doctors or clinics under the Vaccination Programme, and make an appointment for the administration of Sinovac vaccine directly. The list of private doctors/clinics (more than a thousand enrolled doctors at present) is available at the designated website of the Vaccination Programme (https://www.covidvaccine.gov.hk/en/VSS). Moreover, students can also make an appointment at designated Student Health Service Centres for the administration of Sinovac vaccine (Chai Wan Student Health Service Centre, Lam Tin Student Health Service Centre, Sha Tin Student Health Service Centre, Tuen Mun Student Health Service Centre and Western Student Health Service Centre).

2.4 Arrangements for Whole-Day Face-to-Face Classes

In order to tie in with the above priority arrangements for adolescents aged 12 to 17 years to receive Sinovac vaccine, the EDB has updated the arrangements of whole-day face-to-face classes and related activities for the 2021/22 school year. The details are as follows:

If individual schools have achieved the below vaccination rates, the EDB will, taking into consideration the actual circumstances of the schools, allow such schools to arrange whole-day face-to-face classes for students:

- 70% or more of the teachers and school staff (including teaching and non-teaching staff) directly employed by the school have received two doses of COVID-19 vaccine followed by a period of more than 14 days; and
- 70% or more of the students in the whole school have received one of the following vaccines followed by a period of more than 14 days:

Age of Students	Comirnaty Vaccine	Sinovac Vaccine	
18 years or above	2 doses	2 4	
12 to 17 years	1 dose	2 doses	

Remarks:

- 2.4.1 If schools cannot meet the above requirements to resume whole-day face-to-face classes for the whole school, but can meet the above requirements in a particular class level, we can also allow the schools concerned to arrange whole-day face-to-face classes and other activities for students in that particular class level.
- 2.4.2 Please complete and submit the enclosed reply slip. The School will collect data of the students who have received or need to receive the vaccination.
